Minutes of HSS Meeting at City of Costa Mesa, 29 Nov 04

As was reported last month, Bill Eckles had arranged a daytime meeting with the Costa Mesa Parks Department. An extremely effective meeting was held at City Hall on Monday morning 29 November, 2004.

Regarding Improvements to Flying Field at Fairview Park (prepared by bill Eckles)

Topics:

- 1.) Request for Water Access for landing area.
- 2.) Request to grade area of mounds approximately 150 feet north of the walking path beginning with an extension of Canyon Drive and continuing east until it joins with currently graded area.
- 3.) What questions does the Costa Mesa City Council have of current users of the flying field? What could we learn from these current users that would aid in managing city and club liability and minimizing risk of accidental damage?
- 4.) What questions does the Costa Mesa City Council have of other sites in the area? Who should we talk to and what do we want to learn?
- 5.) Other issues?

The meeting began with Bill Morris re-iterating the October 4th City Council approval of the outline Bill Eckles had provided. The detailed minutes of this meeting can be found on the city web site which is located at www.ci.costa-mesa.ca.us . Click City Council, then Full Minutes. The outline is a Power Point presentation available from Bill Eckles.

Topic 3 was addressed first. Bill Morris was very receptive to receiving HSS help on the survey of users. He briefly reviewed the draft survey that Bill Eckles brought to the meeting (Copy attached below). His first recommendation was to add an introduction citing the city approval and authority to perform the survey. Bill Morris will provide further feedback, and requested Bill Eckles to develop the survey details. One final addition that Bill Morris requested was to include user opinions in the survey concerning the permit, He has to have this in order to convince the City Council that a permit system will be accepted.

This initial discussion led Bill Morris to address the general permit concept. While we had not expected any discussion in this area, the most significant progress to date emerged. Bill Morris stated his position as follows: He would prefer not to be responsible for permit procedures as it would be difficult to justify the costs to the city. He wants HSS to manage the permits, assess applicants and monitor field safety. Any required enforcement would still be done by the Park Ranger, based upon new city regulations for flying at Fairview Park. He wants to look upon HSS as an extension of city employees. He would like HSS to handle public

relations with residents and park users, and requested a list of club names that he can call when he gets a complaint. He then requested HSS to lay out a program based upon these points, but to include our initial ideas involving insurance, flying areas, field and safety rules. The result would be a city permit that authorized HSS supervision but Park Ranger enforcement. (It is not clear to me whether he meant a new HSS Use Permit, or a city permit to fly issued by HSS.) The city would make and post all signs. HSS agreed to work up a draft proposal, and work with the city towards a final procedure. Bill Morris was also given a copy of the AMA member insurance summary, and a copy of the Laguna Niguel "Lilly Shapell" rules and procedures.



Topic 2, grading the mounds was brought up, and received positive consideration. All three city members agreed that something might be done to smooth the mounds, however to develop the area to the final design specified in the Master Plan may take 5 years or more. Bruce Hartley and Bart Mejia have agreed to meet Jim Parsons out at the field to discuss what might be done to establish a launch/landing area north of the path, and in the area defined by the Master Plan. This will likely occur about December 10th. They are thinking of something in the order of one day of grading effort. HSS said that we would definitely welcome anything that could be done. Kyle Quatman provided everyone with fresh copies of the Master Plan drawing.

Topic 1, access to water, was blended with topic 2 since this would influence where the piping should be placed. Bill Morris said he would consider giving us a pipe stub and valve for non-potable water. HSS would need to add any extra piping after obtaining a permit. The major problem is health safety, as there must be no way that someone might have access for drinking non-potable water.

Topic 4, survey of other flying sites will be handled by Kyle Quatman with whatever help he needs from HSS. We recommended that he ask about Use Permits, and whether the site owner is covered under AMA insurance. We left copies of the AMA Doc. No. 904 which is the explanation and application for Additional Liability Protection. No one knew if HSS has the City of Costa Mesa specified as "Additional Insured" under our AMA charter club policy.

At the conclusion of the meeting, Kyle Quatman was able to provide HSS with a copy of the License Agreement to place the HSS storage facility (shed) at Fairview Park. A copy of this document will be placed on the new HSS web site (Management Section). An E-mail request was made to Kyle Quatman to see if he could locate a similar License Agreement authorizing HSS to fly at the park.

They said that it seemed do-able and would request funds at the next City Council Meeting. They would also install water for the new area. This seems very positive, and it may be important to have a good showing of club members at that meeting (Date to be supplied).

The Park Department is going to go to the next City Council meeting to ask for funds that could effect our flying field. That is why our club officers think that we ought to have a big turn-out at the next City Council meeting. More on this subject will be discussed at the January club meeting.




AMA Convention January 7 – 9th , 2005

Adopt-A-School Status Report

In mid October, HSS submitted a proposal to Hitec/Multiplex requesting some type of donation to our Adopt-A-School Program. Mike Mayberry of Hitec has recently responded with an astonishingly generous gift in the form of a Multiplex Magister Ready To Fly package. This is a magnificent 65" wingspan electric powered aileron trainer valued at \$300.

It includes a Permax 680 motor with 3:1 gears, an M32 electronic speed control, 1.9 Ahr 8 cell NiMH battery and charger, 4 channel receiver, 3 servos, and a Hitec Laser 4 transmitter.

What is most impressive is that it is made of Elapor foam. Not only is this a new development in BIG crash resistant foam aircraft, this foam is impervious! Regular CA bonds beautifully, epoxy works, acetone does not dissolve it, and you can paint it with anything. A very nice review of the Magister is featured on page 66 of the November 2004 issue of Quiet Flyer. Thanks to Mike Mayberry for a really great plane for our students. 
